**Re: DACA, DREAMERS' Effect on American Black U.S. Citizens**

Black Citizens come to you in, of, and by the authority of the 1866 Civil Rights Act, the Progenitor of the 14th Amendment, by which it's codified into the Constitution, being the National Birth, Identity and Civil Rights of American black citizens, i.e., the descendants of chattel slaves, Jim Crow survivors, et al...

As the only such entity in the nation, the National Conservancy thanks you for courageously and dutifully enforcing the U.S. Constitution against policies and programs such as; DACA (Deferred Action for Childhood Arrivals), i.e., Dreamers", immorally based "I Have a Dream", and DAPA (Deferred Action for Parents of Americans) and Lawful Permanent Residents, which are argued solely on emotional reasoning, not law, or even common sense.

Knowing for decades to be true, we concur with the Honorable President Donald J. Trump who correctly believes and proclaims that "illegal immigration" hurts black citizens more than anybody else, thereby compelling us to help support you in your efforts.
